Four of the conservation easements transferred from, or completed in partnership with, the American Land Conservancy to the Rangeland Trust and are shining examples of how California's land trust community works together to preserve open spaces cherished by all Californians.

#### **COWBOY ISLAND**

**Policy Outreach to Elected Officials** Staff was very involved in policy outreach this year, which pays off in many direct and indirect ways. In July 2011, we participated in a CCA bus tour of the San Joaquin Valley with state legislators and staff. Ranches, easements, and an auction yard were on the itinerary and we were able to build new relationships with these elected leaders. In March, we participated in the Ag Day activities at the Capitol, with legislative visits and the CCA breakfast. Directors Rice, Sweet, Dressler, and Chairman Stone all shared Rangeland Trust's thoughts and positions on myriad legislative issues.

**State Legislation** It was a busy year for legislators in the Capitol as they considered a number of bills that impact our business model and the ranchers we serve. With the leadership of the California Council of Land Trusts, SB 436 (Kehoe) was passed without a single 'no' vote and was signed by the Governor! Unfortunately, apparently no one told the Department of Fish and Game (DFG), as they refused to honor the intent of the legislation. The law sought to correct a DFG policy that prohibited those who hold conservation easements for mitigation purposes from also holding the associated endowments. Given this mind-boggling stance by DFG, a "clean-up" bill was introduced that will address the next round for DFG concerns. SB 1094 (Kehoe) was also pushed through the Legislature and is currently on the Governor's desk for signature. We expect that signature any day. When all said and done, this legislation will allow Rangeland Trust to be the go-to organization for mitigation conservation easements on working ranches in California.

**CCA Fall and Spring Tours** Rangeland Trust directors and staff have been participants in the CCA spring and fall tours, outreaching to the CCA membership and providing accurate information regarding the mission and operation of the organization.

**Leadership through PORT** Rangeland Trust staff, PORT president Darrell Wood and Rangeland Trust Chairman Scott Stone have been very active in working to strengthen the invaluable partnership that exists between seven western states' rangeland trusts. PORT has worked to develop a detailed policy document for the 2012 Farm Bill and the renewal of the Conservation Tax Incentive. This document has been circulated to the Congressional delegations of the PORT member states as well as to other key Congressional members and staff.

**Cooperative Partnerships/Building Alliances** Rangeland Trust staff have been active participants in several partnerships, working to build strategic alliances and promote the mission and goals of the organization. Staff has been active in the California Rangeland Conservation Coalition, the SNC's 'Kitchen Cabinet', CCLT's board of directors and policy committee, Delta Suisun Marsh Land Conservation Working Group, and the Partnership of Rangeland Trusts (PORT) board of directors and committees.

**Death and Taxes** Staff continued to work with our partners and alliances to help maintain the reductions to the federal estate tax and to renew the extension of the federal tax incentive for the donation of a conservation easement. The reduced estate tax is slated to expire at the end of 2012, while the tax incentive expired at the end of 2011. We are continuing to work to educate policy makers and members of the public as to the seriously detrimental impact it has on the family ranch. While the execution of the Death Tax is our ultimate goal, we also recognize political realities and hope to keep the tax rate as low as possible.






